## APPLICATION FOR UNIVERSITY OF KENT SUPPORT FOR NEW INDEPENDENT STUDENTS UNDER 20 YEARS OF AGE

The university is offering the following support to independent students, who are under 20 years of age, and have been in receipt of income support whilst in full time education before starting at Kent. The support is aimed at providing help in areas identified as being of concern to these young people.

- Guaranteed access to accommodation over holiday periods, including the summer vacation
- A one-off £600 cash bursary towards the costs of starting life at University.
- A one-off payment of £100 towards graduation costs for students who attend their graduation ceremony (evidence of booking confirmation in year of graduation required).

You may apply for the support package if you meet the following criteria:

- You are a new, undergraduate student at the University of Kent
- You are under 20 years of age
- You are a UK home fee paying student and have been in receipt of income support whilst in full time education prior to starting at Kent
- You can provide documentation that you were in receipt of income support for a minimum of 6 months immediately before starting at Kent
