5530 Strategic Plan Dashboard Report

The DVC ASP&P introduced the paper **C2022/013 Strategic Plan Dashboard** report, an update on actions following the 2022 strategy day.

5531 Current Performance

The DVC ASP&P presented paper C2022/014(a) Performance Dashboard report.

5532 Student Numbers (Recruitment and Retention) Update

The DVC ASP&P introduced paper C2022/014(a) and (b)

Council noted the report.

5533 Annual Report of the Senate 2021/22

Paper C2022/015 Annual Report of Senate 2021/22 provided key assurance to Council on academic quality. In the absence of the VC, the DVC ASPP drew attention to four key areas:

- Degrees Outcome Statement
- Research Excellence Framework
- Student Wellbeing
- International Partnerships

The University was required to report on the explanation for the rise in the number of First and Upper Second degrees which had occurred during the pandemic. The paper noted that this rise was the result of Covid mitigation measures (including a move to continuous assessment and online exams) but that it had also led to a narrowing of the attainment gap for BAME students. Kim Lowe queried whether it made sense to return to pre-Covid arrangements for exams and suggested that this should be discussed at the strategy day. The DVC ES&E confirmed that there was a need to review how to combine online exams with consistent degree standards.

Action: Council to discuss post-Covid arrangements at the Strategy Day.

The Annual Report from Senate was noted.

5534 Proposed Ordinance on Academic Freedom C2022/016 Ordinance on Academic Freedom as recommended by the Senate

Dr Kelli Rudolph and Martin Atkinson joined Council to introduce the paper. Dr Rudolph reported that the Academic Freedom sub-group of Senate had been working on a proposed Ordinance on Academic Freedom since November 2019. Following external legal advice in March 2022, further work had been undertaken with the Directorate of Governance & Assurance and the Director of HR and OD, to refine the wording of the proposed Ordinance.

Following approval of the proposed Ordinance, Senate would establish a Standing Committee on Academic Freedom and Freedom of Expression to develop a Code of Practice (as required by the HE (Freedom of Speech) Bill, currently making its way through Parliament) and to operationalise the Ordinance. The Code of Practice would set out how the rights and responsibilities of the Ordinance would be exercised.

The proposed Ordinance set out basic principles but further work would be needed on other governing instruments and policies, which would come forward to Senate and Council in due course, including:

- a range of staff processes and other policies such as on whistleblowing and grievances
- Student processes such as Fitness to Practice, Complaints, Appeals and Discipline

Council thanked the team for the effort which had gone into this work over a number of years.

Council **approved** the Proposed Ordinance on Academic Freedom as recommended by the Senate, with an expected effective date of September 2023.

Council approved the Kent Vision funding request.
