Kent Future Student Scholarships



- A guaranteed scholarship no application required and no cap. Applicants must have paid their deposit by **5 December 2025.**
 - Kent Future Student Scholarship Global
 - £2,000 towards the tuition fees
 - Canada, China, Cyprus, France, Germany, Greece, Hong Kong, Indonesia, Italy, Jordan, Malaysia, Qatar, South Korea, Spain, Thailand, Türkiye, UAE, USA Vietnam
 - USA do not need to have paid deposit to be eligible, instead they need to have received an offer, due to Federal regulations
 - Kent Future Student Scholarship Africa: £3,000 towards the tuition fees for those domiciled in Africa
 - Kent Future Student Scholarship India: £5000 towards the tuition fees for those domiciled in India
 - Kent Future Student Scholarship Pakistan: £5000 towards the tuition fees for those domiciled in Pakistan
- Once they receive the scholarship offer letter via KentVision, they must accept the terms and conditions.
- Can be held alongside the KBS Bursary

- £1000 for applicants who have paid their deposit and accepted an offer by 5 December 2025
 - Due to federal regulations, USA students only need to have received and accepted an offer
- Can be combined with the Future Student Scholarship, meaning guaranteed scholarship of up to £6,000 for some applicants
- Multiple scholarships the highest value will be awarded

International Deposit payment




- £5,000, which will be put towards the first year of tuition fees
- Pay by 5 December 2025 to meet the KFSS and KBS Bursary requirements
- Not required if applicants provide
 - Evidence fully funded by a scholarship or sponsor
 - Evidence of US federal loans
- Pay by e-store, and preferably Flywire to speed up the process

International Scholarships for Taught Masters students, January start



- £6000 towards the tuition fees for one year of study
- There is no longer an essay requirement for the scholarship, however students must submit a scholarship application via KentVision.
- Deadline: Friday 14 November 2025, 5pm GMT
- Students must have received a conditional or unconditional offer to be able to submit their scholarship application
- Students must have accepted their offer from Kent by the deadline for their application to be considered
- Cannot be awarded with any other scholarship if a student is in receipt of multiple scholarships, the highest value will be awarded

- Funded jointly by the UK Government's GREAT Britain campaign, British Council and the University of Kent
- £10,000 towards the tuition fees for one year of study
- There is no longer an essay requirement for the scholarship, however students must submit a scholarship application via KentVision.
- Application Deadline: Wednesday 19 November 2025, 5pm GMT
- Criteria: French passport holders living in France, or Indian passport holders living in India, and an overseas fee payer, applied for one year taught masters course start in January.
- Applicants must be active in the field with work experience or proven interest in the subject area, and be willing to act as an ambassador for UK Higher Education
- Students must have received a conditional or unconditional offer for a programme to be able to submit their scholarship application
- Students must have accepted their offer from Kent by the deadline for their application to be considered
- Cannot be awarded with any other scholarship if a student is in receipt of multiple scholarships, the highest value will be awarded

LLM Global Welcome January Scholarships



- A first come first served stipend £2,500 given to applicants who meet the eligibility conditions and submit a scholarship application by the deadline.
- For overseas fee payers from any country which receives Official Development Assistance (ODA) from the OECD, which includes Thailand, India, Nigeria, Kenya, Brazil, China, Turkey
- For student studying a full-time, taught LLM.
- Eligibility for the award will be assessed after an application has been submitted.
- To be considered, applicants must have applied for a place on the course, have received an offer, and have submitted a scholarship application by the deadline of **2 December 2025** 23:59 GMT.
- Cannot be awarded with the international, GREAT or Future Student scholarships

Thailand Second LLM Scholarship - Law



- A stipend of £3,000 to the first 25 eligible applicants who meet the eligibility conditions and submit a scholarship application by the deadline.
- A limited number of scholarships available; awarded on a first come first serve basis.
- Applicants must hold a valid passport demonstrating that they hold Thai nationality.
- For self funded Thai applicants who have completed or are currently studying for a taught LLM at the University of Kent, and who have applied for a second taught Kent LLM for January 2026.
- Eligibility for the award will be assessed after an application has been submitted.
- To be considered, applicants must have applied for a place on the course, have received an offer, and have submitted a scholarship application by the deadline of 2 December, 2025 23:59 GMT.

- Funded jointly by the UK Government's Study UK GREAT Britain campaign, British Council and the University of Kent
- £10,000 towards the tuition fees for one year of study
- There is no longer an essay requirement for the scholarship, however students must submit a scholarship application via KentVision.
- Application deadline: Friday 24 April 2026
- Applicants must have Ghanaian, Indian, Kenyan, Malaysian, Nigerian, Thai or Turkish nationality, and be living in the same country (overseas fee payers). These countries change each year
- Applicants must be active in the field with work experience or proven interest in the subject area, and be willing to act as an ambassador for UK Higher Education
- Students must have received a conditional or unconditional offer for a one year programme at a UK campus to be able to submit their scholarship application. Students who have applied for a Year in Industry or integrated masters aren't eligible.
- Students must have accepted their offer from Kent by the deadline for their application to be considered

September: Postgraduate Research students



- Research scholarship deadlines are often early in the academic year, so best to apply early
- Some Schools offer PhD scholarships for any topic, but in the Sciences, funding is available for research on a particular topic
- SEDarc, South-East Doctoral Training Arc (Economic and Social Research Council) funded
 - Deadline: Sunday 23 November 2025 23:59 GMT
 - Includes a Doctoral Stipend, tuition fees and research support funding.
 - Programmes eligible include Business, Psychology, Law, Politics and Architecture
- University of Kent/Huawei School of Computing PhD Studentships
 - Deadline: Sunday 30 November 2025 23:59 GMT
 - Includes a Doctoral Stipend, tuition fees and research support funding.
 - PhD topic: "Digital Trust in the Computing Continuum: Trustworthy Path Agility for Computing Continuum transactions."
- Kent Business School Graduate Teaching Assistantship
 - Deadline: Friday 30 January 2026
 - Includes tuition fees, a maintenance grant and salary equivalent to the Doctoral Stipend for up to 3.5 years
- AHRC Doctoral Awards (Arts and Humanities Research Council)
 - Deadline: Monday 16 February, 2026 23:59 GMT
 - Includes a Doctoral Stipend, tuition fees and research support funding.
 - Programmes eligible include Arts and Architecture, English Literature, History, Law and Politics

Music and Sport Scholarships



Music performance scholarships:

- Up to fifteen Music Performance Scholarships to talented instrumentalists and singers.
- Students applying to any subject can be awarded a scholarship worth up to £1,000, and £500 of tuition with experienced teachers.
- Around 15 scholarships available each year
- Apply via the website, and then audition upon arrival
- There is no deadline prior to the start of the academic year, but early application is advisable.

Sports scholarships

- Includes premium plus Kent Sport membership
- Weekly training sessions with Kent Sport's specialist instructors.
- Physiotherapy and rehabilitation programmes
- Exclusive workshops available to scholars
- Up to £1000 financial support towards sporting events, sessions and fixtures or competitions
- Apply via the Kent Sport website
- Deadline 30 April 2026
